

RESOLUTION NO. 24-118

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA
TO CONTINUE EXISTING SERVICE CHARGES FOR COUNTY SERVICE AREA NO. 14
FOR FISCAL YEAR 2024-25**

WHEREAS, the Board of Supervisors of the County of Ventura (Board), acting as governing authority for County Service Area (CSA) No. 14, previously fixed charges for extended services for CSA No. 14 pursuant to County Ordinance No. 3428 which was enacted pursuant to Government Code section 25210.7a and given continuing effect through Government Code section 25210.3(d); and

WHEREAS, a report pursuant to County Ordinance No. 3428, Ventura County Public Works Agency (PWA) prepared and filed with the Clerk of the Board a report entitled "County Service Area No. 14 Report Per County Ordinance No. 3428 Fixing Charges for Fiscal Year (FY) 2024-25" (Report); and

WHEREAS, the Report includes a "Vicinity Map CSA 14" (Exhibit 2), "Area Map CSA 14" (Exhibit 3), and a report entitled "County Service Area No. 14 (Casa Conejo) Service Charges for Fiscal Year 2024-25" (Exhibit 4), which sets forth proposed Fiscal Year (FY) 2024-25 CSA No. 14 service charges in amounts that do not exceed the estimated reasonable cost of providing the services; and

WHEREAS, the proposed FY 2024-25 CSA No. 14 service charges set forth in the Report remain unchanged since FY 2004-05 and are therefore exempt from the notice and protest provisions of Proposition 218; and

WHEREAS, the Public Works Agency published notice of today's hearing on the proposed FY 2024-25 CSA No. 14 charges in accordance with the requirements of County Ordinance No. 3428; and

WHEREAS, the Board conducted a public hearing on July 23, 2024, and has heard and considered all oral and written comments, protests, and objections timely received concerning the Report and the proposed FY 2024-25 CSA No. 14 service charges; and

WHEREAS, section 5-4 of County Ordinance No. 3428 authorizes collection of these charges at the same time and in the same manner as ordinary County property taxes (with the exception of the parcels which are billed manually).

NOW, THEREFORE, BE IT RESOLVED that the Board approves and confirms the Report, the FY 2024-25 CSA No. 14 service charges at the rates described therein, and the continued collection of CSA No. 14 service charges described in the Report as part of the annual general County tax roll for FY 2024-25.
