Dear Michelle Ascencion,


I am writing to you with deep concerns about the Voters Choice Act. The continued use of mail in ballots and unsecured drop boxes along with centralized ballot tabulation machines creates a privation of integrity. Same day voter registration should be removed for its inability to verify eligibility to vote. These methods, while intended to enhance accessibility and efficiency, unfortunately, also create easy opportunities for nefarious actors to engage in fraudulent activities.

As outlined in CA. Elections code 19101 Sec. B, it is imperative that our election system remains safeguarded from fraud and manipulation. However, numerous investigations and legal disputes across the country have exposed vulnerabilities in the security of ballot tabulation machines, contrary to the standards set forth in state law.



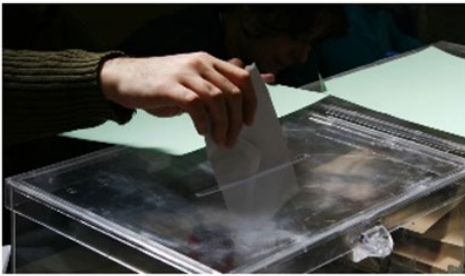

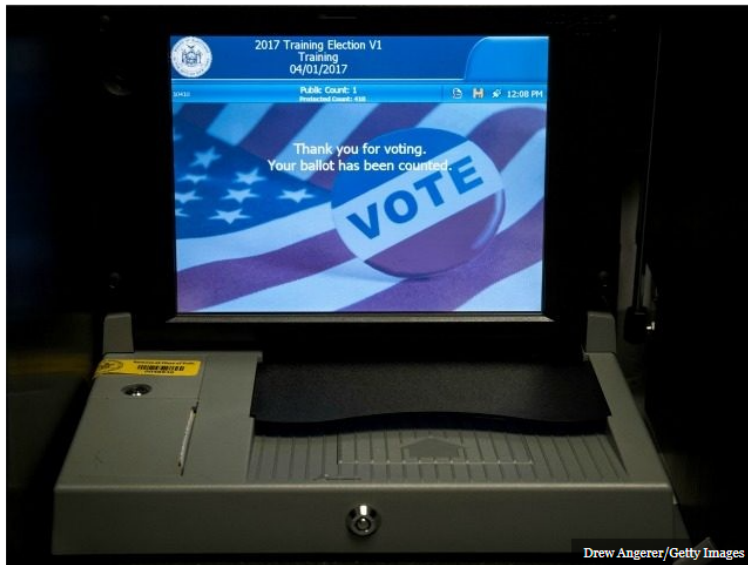
