

AMENDMENT ONE TO THE PROVIDER SERVICES AGREEMENT

This Amendment to Professional Services Agreement (this "Amendment"), made effective as of **January 1, 2023** (the "Effective Date"), and amends that certain Professional Services Agreement (as amended, the "Agreement") entered into between **CARELON HEALTH IPA OF CALIFORNIA**, formerly known as College Health IPA, a California medical professional corporation with its principal office at 12898 Towne Center Drive Cerritos, CA 90703 ("CHIPA") and **County of Ventura** ("Provider").

WHEREAS, CHIPA and Provider entered into a Provider Services Agreement ("Agreement") effective as of September 23, 2015;

WHEREAS, the Parties agree to amend the Agreement in accordance with the Amendment provisions therein;


WHEREAS, College Health IPA of California has legally changed its name to Carelon Health IPA of California effective March 1, 2023. NOW, THEREFORE, in consideration of the promises, agreements and other good and valuable consideration as hereinafter set forth, the CHIPA and Provider agree to amend the Agreement as follows:

1. Exhibit A is hereby deleted in its entirety and replaced with a new Exhibit A (Services and Rates) effective **January 1, 2023**, attached hereto and incorporated into the Agreement.
2. Name Change. All references in the Agreement to "College Health IPA of California" or "CHIPA" are changed to read "Carelon Health IPA of California" and "CHIPA" respectively.
3. Except as amended pursuant to this Amendment, all other terms of the Agreement shall remain unchanged and in full force and effect.

CARELON Health IPA (CHIPA) MEDI-CAL
SERVICES & RATES
Effective January 1, 2023

This Exhibit A applies to Members of the following Plan(s) for the specified line(s) of business below.

Gold Coast Health Plan – Medi-Cal

PROFESSIONAL SERVICES REIMBURSEMENT

Carelon Health IPA (CHIPA) shall reimburse Provider for Services rendered to Members of Plans designated in the line(s) of business above, according to the fee schedules for such line of business, as set forth below. Unless prohibited by law, CHIPA shall reimburse Provider the lesser of billed charges or the applicable rates specified in the fee schedule(s). Reimbursement is subject to any applicable Member cost share, deductible, or co-payments.

Carelon Health IPA (CHIPA) will provide 90 days' advanced notice to providers in the event of changes to the Exhibit A Services and Rates fee schedules.

CHIPA MEDI-CAL LINE OF BUSINESS

Reimbursement:

1. Services covered under Members' benefit plan and rendered by Providers who are licensed to prescribe medications shall be reimbursed at 120% of the Medi-Cal fee schedule, as published by the California Department of Health Care Services, and applicable to the date of service.
2. Services covered under Members' benefit plan and rendered by Providers who are not licensed to prescribe medications shall be reimbursed at 100% of the Medi-Cal fee schedule, as published by the California Department of Health Care Services, and applicable to the date of service.
3. Services covered under Members' benefit plan and rendered by Interns will be paid at 80% of the Medi-Cal fee schedule, as published by the California Department of Health Care Services, and applicable to the date of service.
