

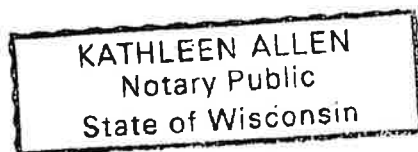

ARTICLES 2, 3, 5, 7, 8, AND  
19 OF THE VENTURA  
COUNTY NON-COASTAL  
ZONING ORDINANCE TO  
ESTABLISH A NEW  
URBAN PARKS USE  
CATEGORY, AND OTHER  
AMENDMENTS TO THE  
VENTURA COUNTY  
GENERAL PLAN - LAND  
USE ELEMENT REGARD-  
ING URBAN PARKS

NOTICE IS HEREBY given  
that a public hearing, as  
provided by law, was held by  
the Ventura County Board of  
Supervisors on Tuesday,  
January 9, 2024, at 3:00 p.m.  
to consider and decide the  
ordinance described below.

SUMMARY OF ORDI-  
NANCE NO. 4624: The  
adopted ordinance amends  
Articles 2, 3, 5, 7, 8, and 19 of  
the Ventura County Non-  
Coastal Zoning Ordinance.  
The ordinance amendment  
included the establishment of  
a new Urban Parks use cate-  
gory, definition, lot area  
exception, and development  
standards for Urban Parks.  
Other related amendments  
included updating the permit  
types for Athletic Fields,  
Natural Parks with Build-  
ings, and County Initiated  
Recreation Projects. Also  
included in the ordinance are  
minor revisions to the Park-  
ing and Loading Standards in  
Article 8, and the Old Town  
Satellite Development Code,  
Section 8119-1, Article 19.  
PL22-0056 also included adop-  
tion of a resolution for a  
County-initiated amendment  
to the Ventura County  
General Plan - Land Use  
Element that 1) repealed the  
Parks and Recreation Land  
Use designation, 2) repealed  
the Recreation zone, 3)  
repealed Goal LU-12 and  
Policy LU-12.1, 4) amended  
Goal LU-16, and 5) added a  
new Policy LU-16.11.

ENVIRONMENTAL  
REVIEW: The project does  
not require additional review  
under the California Envi-  
ronmental Quality Act  
(CEQA) pursuant to CEQA  
Guidelines Section 15168(c)  
(2) because adoption of the  
ordinance is a later activity  
within the scope of the certi-  
fied 2040 General Plan Envi-  
ronmental Impact Report  
(EIR) and does not require a  
subsequent EIR.

The ordinance and related  
General Plan amendments  
were adopted by the follow-  
ing vote:

AYES: Supervisors Lopez,  
Porvin, Gorell, LaVere, and  
Long

NOES: None

ABSENT: None

The ordinance and related  
General Plan amendments  
take effect 30 days after the  
date of adoption.
