**SUBJECT: Approval of Appointments to the Local Planning Council (LPC) of Ventura County for Terms Ending June 1, 2024: AnnaMarie Aguilar to the Appointed Category, Amber Abraham to the Child Care Consumer Category, and Daisey Valadez as the Alternate to the Public Agency Representative Category**

### **Recommendation**

Approve the appointment of AnnaMarie Aguilar to the Appointed category, Amber Abraham to the Child Care Consumer category, and Daisey Valadez as the Alternate to the Public Agency Representative category for terms ending June 1, 2024.

### **Discussion**

The California Education Code section 8499.3 [Welfare and Institution Code (WIC) sections 10480 and 10485-10487] requires each county to establish and operate a Local Planning Council. The Board of Supervisors and Superintendent of Schools each select one half of the members to serve on the Council and establish terms of office. Categories of membership are to include: 20% consumers; 20% providers; 20% public agency representatives; 20% community representatives; and 20% discretionary.

Duties of Local Planning Councils are varied, ranging from development of a needs assessment (supply, demand, cost and market rates) and preparation of a comprehensive, countywide childcare plan designed to mobilize public and private resources to address identified needs, the coordination of providers, programs, waiting lists, public education and training.

Locally, the Local Planning Council of Ventura County desires to have a membership of 25 individuals. The LPC Executive/Membership Committee, on behalf of the Local Planning Council of Ventura County, is requesting the assignment of AnnaMarie Aguilar to the Appointed category and Amber Abraham to the Child Care Consumer category. In accordance with Council bylaws, the Executive Committee also recommends the appointment of Daisey Valadez as a member alternate for current Council member Ernesto Duran.

The LPC Executive/Membership Committee, on behalf of the Local Planning Council of Ventura County, agrees with the appointment of the following members for the remainder of 2022 – 2024 Council term:
