I am writing to express my interest in serving on the Ventura County Transportation Commission (VCTC) as a Citizen Representative Commissioner. I have been the County of Ventura's Disability Access Manager since September of 2022 and within that period of time, established the County's Office of Disability Access, created and received unanimous Board of Supervisors support of the first Disability Access Strategic Plan which includes a transportation accessibility goal, managed the ongoing County-wide ADA Assessment and Transition Plan process, and successfully hosted a first of its kind Government and Disability Summit, among many other exciting disability community benefitting efforts.

For the first year of my County employment, I, a wheelchair user and resident of Camarillo was reliant on public transportation to get to/from work and around the community. During this time, I began attending VCTC Meetings and advocating for a more user friendly, accessible, streamlined system. I believe there have been several wins on those fronts within the last couple of years including the County now having an accessible on-demand transportation option, soon having the first round of motorcoaches with a low-floor ramp rather than lift option, and an increased focus on accessibility in general.

I am confident that including the disability perspective through a Citizen Representative Commissioner with lifelong lived experience, born and raised in Ventura County would be a huge benefit to the VCTC and I hope you agree!
