I am very interested in being considered for the position of Ventura County Transportation Commission Citizen Representative Commissioner. I feel that I bring to the Commission three significant qualifications.

First, having been the Director of Transit for VCTC for approximately 15 years, ending in 2015, I have talked to hundreds of County residents over their concerns regarding the availability and quality of transportation in the county. These discussions were through a variety of means, including the annual unmet needs process, but also by taking hundreds of phone calls - often by people who had complaints with the existing service. This gives me a significant level of insight into what worked, what didn't work, and what at least some of the population felt was needed. While I have not been in that situation since 2015, I feel I can still represent some of the concerns that exist, and understand the related information the staff brings to the Commission.

Second, I have a very strong knowledge of both the various parts of the County and the transit providers. I have either worked for or lived in the Cities of Ventura, Oxnard, Thousand Oaks, and Simi Valley, in addition to my work for VCTC, and much earlier, the County of Ventura (both Mental Health and Planning Departments). I also served three terms on the Ventura County Grand Jury, which gives me additional insights into the various cities – beyond the transportation realm. Several years after retirement, I also served on the VCTC Citizens' Transportation Advisory Committee, and have continued to keep in communication with many of the staff of the transit providers in the County, sharing information about funding opportunities and new state and federal requirements.

While I have feel for some of the county residents, I also have a good understanding of the funding and regulatory constraints which the cities face in dealing with the cities have.

Third, I have a deep interest and involvement in transportation. I spent over 50 years as a transportation professional, working for regional agencies and cities. I have been responsible for traffic engineering and operations, freeway call boxes, highway funding, transit funding and operations. I also taught 20 quarter classes in transportation planning at both Cal Poly San Luis Obispo and Cal State University Long Beach as a

part-time faculty member, while also team teaching 3-day classes in Regional Transportation Planning for the UC Institute of Transportation Studies (ITS).

Since retiring, I have continued to be involved in the transportation world, attending most of the California Transit Association annual conferences, and keeping up an active involvement in a number of different Transportation Research Board Committees, dealing with diverse issues including Commuter Rail, Transportation and Economic Development, Transit Standards, and the update to the Highway Capacity Manual.

Because I am retired, I have the time to commit to the activities of the VCTC, and whatever outside committees the Commission would have me serve on.
