Clerk of the Board and County Board of Supervisors:

I am writing to commend Michelle Ascencion and her election team on another round of successful elections. After working in our local county elections in the past, I learned what it takes to run safe and secure elections and our election workers look into every detail. Paper ballot numbers are matched with the machine scanned ones and every number is recounted by two or more workers.

I watched the 4 videos by the election office showing every detail and procedures of our newest systems and any questions I had were answered by those videos, especially the last one concerning fraud. I'm especially pleased that at the election centers every registered voter will get his appropriate ballot for his own area, since so many voters used to go to a polling place where they were not assigned and had to receive a provisional ballot. This is of special concern where there are so many jurisdictions in the Oxnard, Port Hueneme, and Ventura areas, and will assure that the voter will be able to vote for the candidates for his/her particular town or district.

We have no need for an Election Inspectors Office, nor an Election Oversight Commission. The election team works very effectively and efficiently as is, checking every detail. We also have safe procedures in place for every registered voter to vote over several days and ways which make it very easy for all citizens to vote, wherever they are, here or abroad, by the deadline. The ballot counts and recounts compared with the machine totals mean there is no need for additional audits, unless there is a problem. Because of the growing number of people in our county it is important that the ballots are processed in a timely manner. It takes time (especially to check the envelope signatures manually as well as by machine), and it's good to be able to start processing them early if they have been received, so we can get the results in a timely manner.

I have been concerned about what I hear about elections in other states and people trying to cause problems and thank God every day that I live in California, and especially Ventura County where we have free, fair, and safe elections.

Thank you again for all your hard work.

Dear Supervisors of the County of Ventura,

As a registered voter in District 2, I want to state unequivocally my support for maintaining the existing Ventura County elections system as it is. I request that all of the Board of Supervisors reject the demands of this special interest group to alter the elections system, no doubt conceived in the favor of this group's own interests.

Please do not accede to the demands:

- 1) to reinstate an independent Election Fraud Hotline and Election Inspectors Office, as these were never pre-existing parts of our elections system.
- 2) to appoint a Citizen's Election Oversight Commission, as there is no grounds to believe that any such commission is necessary based on the compliance of Ventura County elections with state and federal laws, and any such commission would thus be a waste of taxpayer money.
- 3) to limit precinct elections to one day in Ventura County, as this would be a burden on many Ventura County residents and would make it all too easy to suppress the vote within Ventura County.
- 4) to require a citizen's hand audit to accompany the use of any electronic tabulating machines, as there is no evidence of electronic voting machines being more unreliable or untrustworthy than human tabulation.
- 5) to not allow the processing of ballots before Election Day, as this contravenes state law and would create an additional burden on the elections system

Our current elections system functions imperfectly, but quite well enough as it is, and I do not see any reason to believe that submitting to this group's demands will do anything but undermine it. Please uphold and maintain our current system.
