The purpose of this Change Order is to: *(highlight the key reasons for this Change Order)*

This Change Order # 001 incorporates mutually agreed upon changes associated with completion of the Detailed Design Review (Refresh DDR, 2/6/2024) and as otherwise requested by Customer into the Ventura County 700 MHz and Microwave Project (CA-191159A):

1. Update Base system design,
2. Incorporate GenWatch 3 solution for system monitoring and management,
3. Change from on-premise Radio Management to Motorola-hosted Radio Management,
4. Implement enhanced microwave (MW) capacity, and
5. Provide CirrusCentral Core and Management also known as Virtual Core.
6. Incorporate the Addendum for Transport Connectivity (TCA), included within Section 9.1 (Contractual Documentation) of Attachment A, Exhibit 1, to the Contract as Exhibit E.

The base system design updates account for site changes and updates that evolved during the DDR review and approval process; resulting in equipment adjustments (credit), a true up of the cost of the base MW design (credit), and additional T1 migration services.

The price for this Change Order includes Year 1 fees that are with support and services for Hosted Radio Management, GenWatch 3, CirrusCentral Management and Core, and Astro Connectivity Services (ACS): \$1,505,623.

Support and subscription pricing are provided for Years 2 - 5 (Attachment A). The pricing for Years 2-5 of the Support and Subscription Services after Year 1 is \$1,209,185. This subscription pricing can be bundled with the Maintenance and SUA Services.

The total price of the True-Up, Enhancements, and Support/Services (Years 1-5) is \$2,714,808.

Motorola's scope of work as outlined in Section 2: Implementation Plan is herewith modified as follows:

1. Update Base system design resulting from the completion of the Detail Design Review,
2. Incorporate GenWatch 3 solution for system monitoring and management (See Section 1.6: GenWatch System Monitoring & Management of Attachment A for details),
3. Change from the original on-premise Radio Management to Motorola-hosted Radio Management (See Section 1.7: Hosted Radio Management of Attachment A for details),
5. Implement enhanced microwave (MW) capacity (See Section 1.8: Enhanced Capacity Microwave System of Attachment A for details),
6. Provide CirrusCentral Core and Management also known as Virtual Core (See Attachment A, Exhibit 1 for details), and,
7. Provide associated support and services.

SUA/Support Service Changes: (additions, deletions or modifications)

SUA/Support Service Changes are herewith modified as follows:

- Additional RM Hosted Licenses and GenWatch maintenance.
- SUA remains as is.

Note that subscription pricing is provided on an annual basis. The Change Order total reflects 1 year costs associated with ACS, CirrusCentral, GenWatch 3, and Radio Management.
