**Discussion:**

On March 26, 1996, voters in the City of Ojai passed a Library Parcel Tax. The tax was to provide funding for an improved level of service at the Ojai Library. On June 13, 2023, the Ojai City Council approved the attached Twenty-Seventh Amendment to the Agreement for the County of Ventura to Provide Additional Library Services to the City of Ojai. Per the Library's original agreement with the City of Ojai, this parcel tax money provided for an additional 31 hours per week of open hours and expanded services consisting of a full children's program for the Ojai Library.

This amendment renews the original agreement between the County and the City of Ojai, first adopted in 1996. Revenue of \$106,000 from the Twenty-Seventh Amendment to the agreement is included in the Library's Fiscal Year 2023-24 Adopted Budget. We ask that your Board approve this amendment, authorize the Chair to sign the amendment.
