**SUMMARY OF AN  
ORDINANCE OF THE

REPEALING VENTURA  
COUNTY ORDINANCE NO.  
4339 AND ESTABLISHING  
REVISED COUNTY  
CHARGES FOR  
PROVIDING COPIES OF  
PUBLIC RECORDS**

The following is a summary of a proposed County of Ventura ("County") ordinance to be considered by the Ventura County Board of Supervisors for adoption on February 27, 2024, in the Board Hearing Room in the Hall of Administration (HOA), County Government Center, 800 S. Victoria Ave., Ventura, CA.

The purpose of the ordinance is to repeal Ventura County Ordinance No. 4339 and to establish new County charges for providing copies of public records. Such charges consist of the following: the County's actual costs incurred in printing copies (based on General Services Agency's internal County rates that are currently \$.035 per page for black and white and \$.105 per page for color copies), providing records on data storage devices, mailing copies of records, and charges authorized by Government Code section 7922.575(b). However, charges are waived if the total recoverable cost of fulfilling a public records request does not exceed \$10.00.

This summary is presented pursuant to California Government Code section 25124(b). A certified copy of the full ordinance is available for review at the Office of the Clerk of the Board of Supervisors located in the HOA at the above-stated address.
