AN AMENDMENT TO THE
VENTURA
COUNTY ORDINANCE
CODE, DIVISION 1,
CHAPTER 3, ARTICLE 4,
CIVIL SERVICE SYSTEM
The Board of Supervisors of the County of Ventura does ordain as follows:
Section 1. Section 1347 of the Ventura County Ordinance Code, Division 1, Chapter 3, Article 4, Civil Service System, is hereby amended by the addition of the following exceptions to the classified service position:
Section 1347-191 Assistant Director Behavioral Health
Section 1347-192 Behavioral Health Division Manager-E
Section 2. Section 1347 of the Ventura County Ordinance Code, Division 1, Chapter 3, Article 4, Civil Service System, is hereby amended by the amendment of the title of the following exception to the classified service position:
Section 1347-146 FROM: Assistant Director Behavioral/Public Health Services
TO: Assistant Director Public Health
Section 3. This ordinance shall take effect thirty (30) days after its adoption.
