

**FOURTH AMENDMENT TO THE ORGANIZATIONAL PROVIDER AGREEMENT
BETWEEN THE COUNTY OF VENTURA AND PARKSIDE HEALTHCARE, INC.**

This "Fourth Amendment" to the Agreement for Adult Residential Treatment Services, which became effective July 1, 2023, is made and entered into by and between the **COUNTY OF VENTURA**, acting through its Behavioral Health Department (VCBH), a primary service provider, hereinafter referred to as "COUNTY", and **PARKSIDE HEALTHCARE, INC. (dba PARKSIDE HEALTH AND WELLNESS CENTER)**, hereinafter referred to as "CONTRACTOR".

NOW, THEREFORE, the parties hereby agree that the Agreement, is amended as follows:

- I. Effective with respect to the service period commencing July 1, 2023, through June 30, 2024, Exhibit "B" (PAYMENT TERMS) subsection A of the Agreement is amended to read as follows:
 - A. The maximum total amount of this Agreement shall not exceed **\$1,416,600** for the service period of July 1, 2023 through June 30, 2024.
- II. Except for the modifications described herein, all other terms and conditions of the Agreement, as previously amended, shall remain in effect.
- III. This Fourth Amendment may be executed in counterparts, each of which shall constitute an original, and all of which taken together shall constitute one and the same instrument.
- IV. The parties hereto agree that this Fourth Amendment may be transmitted and signed by electronic or digital means by either/any or both/all parties and that such signatures shall have the same force and effect as original signatures, in accordance with California Government Code Section 16.5 and California Civil Code Section 1633.7.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Ensign Services, Inc. (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
