STRATEGIC PLAN PRIORITY:

The item presented in this Board letter supports the Healthy, Safe, and Resilient Communities strategic priority of the County Strategic Plan as it is designed to meet the goal of providing access to quality healthcare required for our community to thrive.

DISCUSSION:

Cigna is a managed health care company that offers various commercial insurance products commonly known as HMO and PPO benefit plans. The County of Ventura has maintained a professional services contract with Cigna since November of 2006. The County of Ventura and Cigna continue negotiating a new base agreement for a multi-year term. In the interim, this First Amendment provides rate increases that will enhance revenue from this contract by nearly forty-seven percent (47%) over a one-year period.

The portions of the agreement concerning compensation paid to HCA are exempt from disclosure under the Public Records Act (Health and Safety Code Section 1457 (c) (1)). If the Board would like further information regarding the rates, the original agreements are retained by Mike Taylor, HCA Chief Financial Officer.
