1-12	3501	Multiple Vendors (see description for names and amounts)	<p>Senior Nutrition Program: This program provides high-quality, nutritionally balanced meals, nutrition counseling and education, companionship, and related supportive services to persons aged 60 years and older, through congregate meals (in an atmosphere that is pleasant and encourages socialization) and home-delivered meals (to those who are homebound), giving preference to those in the greatest economic or social need. The goals of the program are to maintain or improve the physical, psychological, and social well-being of older individuals by providing or securing appropriate nutrition services, reducing hunger and food insecurity, promoting socialization, and promoting health and well-being to delay the onset of adverse health conditions resulting from poor nutritional health or sedentary behavior.</p> <p>The program is operated in several cities and unincorporated communities throughout Ventura County. Those contracted to provide the congregate and home-delivered meals and their contracted amounts are itemized below. These are renewing contracts. The year-over-year increase in the budgeted amount reflects a shift from the current process whereby the vendors will begin ordering and paying the cost of meals and supplies directly from their suppliers then seek reimbursement from County, rather than County ordering on their behalf and paying the suppliers directly. 13	3501	Long Term Care Services of Ventura County, Inc.	<p>Long Term Ombudsman and Pre-placement Counseling: The Ombudsman Program advocates for the health, safety, welfare and rights of individuals living in long-term or extended care facilities. Ombudsman representatives are specially trained to investigate and resolve complaints, observe and monitor the condition of residents and facilities, provide information about available ombudsman services and ensure that the residents have timely access to those services. They also provide Family Caregiver Nursing Facility Preplacement Counseling for family caregivers considering placement of a loved one into a skilled or resident care facility. The Ombudsman and Preplacement Counseling program operates with seven staff and approximately 35 volunteers. 14	3413	Aspiranet	<p>Resource Family Approval Family Evaluations: Resource Family Approval (RFA) is the state-mandated caregiver approval and support process for children involved in the child welfare and probation systems. The RFA Family Evaluation is an assessment that creates a comprehensive picture of the prospective caregiver(s) by exploring their family dynamics and characteristics, including mental, physical, and emotional health. The contractor will provide evaluations of up to 144 individuals and families during the contract year who are interested in becoming a placement for children in out-of-home care.</p> <p>The Resource Family Approval Family Evaluations program has been operating successfully for several years with two contractors. There has been a reduced need for the quantity of resource families in recent years, thus a decision was made to consolidate the evaluations into one contractor. A procurement was conducted earlier this calendar year for renewed competition, with three bidders submitting proposals. 15	3413	Casa Pacifica	<p>Moving Forward Together: The purpose of this contract is to provide in-home therapy to parents who need to develop life skills so that they may provide their children with a safe and nurturing environment in which to develop their full potential, free from all forms of abuse and neglect. Families receive frequent, short-term, in-home therapy to prevent family separation or to support the return of children to the home setting from out-of-home care.</p> <p>Since July 1, 2024, Contractor has provided services to 21 families. The year-over-year increase in the contract amount is due to the recruitment efforts of a bilingual mental health clinician.</p>	\$450,000	\$470,000
16	3413	Compass Family Enterprises, Inc., dba Channel Islands Social Services	<p>Foster/Resource Respite Care: The purpose of this contract is to promote family strengthening by providing respite care services for Ventura County foster/resource and Family Preservation families caring for children. This support service for foster/resource families is designed to retain foster families by giving them a temporary break from the daily care of foster children, thus helping to avoid stress and burn-out for caregivers. The contractor will provide in-home respite care to foster/kinship and Family Preservation families, who may use up to 12 hours per month. The contractor will provide up to 10,200 total respite care hours for up to 135 families. Contracted service hours also include a total of up to 467 childcare hours for birth families to participate in Child Family Team meetings and community events.</p> <p>This is a renewal contract. Since July 1, 2024, the contractor has supported 95 foster/resource families actively using respite care and has provided 3,617 respite care hours.</p>	\$250,000	\$250,000

21	3415	Goodwill Industries of Ventura and Santa Barbara Counties	<p>Expanded Subsidized Employment Program: Assembly Bill 74 (2013) authorized the state to implement the CalWORKs Welfare-to-Work (WTW) Expanded Subsidized Employment (ESE) Program as a part of an effort to increase early engagement strategies among eligible CalWORKs participants. The intent of this program is to increase the Human Services Agency's CalWORKs workforce participation rate and improve CalWORKs participants' work maturity skills by providing up to six months of paid work experience. The contract provides funding to cover 100% of a participant's wages and allowable fringe benefits during the work experience assignment and provides for contractor operational costs. The goal of the program is to improve the participant's work skills and abilities and to help them obtain unsubsidized employment and ultimately leave public assistance. The contractor will provide sufficient services to place 50 participants into subsidized work experience. The goal is that 70% of CalWORKs participants enrolled in the program will complete six months of subsidized work experience and a minimum of 30% of enrolled participants will secure unsubsidized employment.</p> <p>This is a renewal contract.
