SUBJECT: Community forum to provide information to the public concerning Immigration and Customs Enforcement access to individuals housed in County jail facilities in 2023 in accordance with the Transparent Review of Unjust Transfers and Holds (TRUTH) Act.

Recommendation:

Hold a community forum to provide information to the public concerning Immigration and Customs Enforcement (ICE) access to individuals housed in County jail facilities in 2023 in accordance with the TRUTH Act.

Strategic Priority:

The item presented in this Board letter supports the County Strategic Plan values of ethical behavior, transparency, accountability, equitable treatment and respect of all constituents. The item also aligns with the strategic plan priority of healthy, safe, and resilient communities.

Discussion:

The TRUTH Act, codified in part at Government Code sections 7283-7283.2, requires the local governing body of any county or city in which a local law enforcement agency has provided ICE access to an individual during the last year to hold at least one community forum that is open to the public during the following year to provide information to the public about ICE's access to individuals and to receive and consider public comment. Because the Sheriff's Office has provided ICE with access to an individual within the last year, your Board is required to hold a community forum to share information with the public concerning the access provided. Notice of today's community forum was posted to the public at least 30 days in advance in accordance with the TRUTH Act.
