

**SIXTH AMENDMENT TO  
AMENDED AND RESTATED HOSTED SOFTWARE SUBSCRIPTION AGREEMENT**

Recitals

- A. Huron and County are parties to Amended and Restated Hosted Software Subscription Agreement dated March 27, 2018, as amended (the “Agreement”), pursuant to which Huron makes available to County its hosted revenue cycle analytics software and revenue cycle workflow software (the “Software”).
- B. The parties wish to extend the Term of the Agreement as set forth below.

NOW, THEREFORE, the parties, in consideration of the mutual agreements herein contained and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, do hereby agree as follows:

Agreement

- 1. This Amendment is effective as of July 1, 2023 (the “Effective Date”).
- 2. Effective as of the Effective Date, section 3.1 of the Agreement shall be modified as follows:
  - 3.1 Renewal. Upon expiration of the Initial Term on May 8, 2019, and upon expiration of each Renewal Term thereafter, this Agreement shall renew upon written agreement (each a “Renewal Term”), unless earlier terminated pursuant to Section 8 of this Agreement. The first Renewal Term shall be from May 9, 2019 through May 8, 2020. The second Renewal Term shall be from May 9, 2020 through June 30, 2021. The third Renewal Term shall be from July 1, 2021 through June 30, 2022. The fourth Renewal Term shall be from July 1, 2022 through June 30, 2023. The fifth Renewal Term shall be from July 1, 2023 through June 30, 2024. Each Renewal Term is also a Segment. Collectively, the Initial Term and all Renewal Terms are the “Term.”
- 3. Effective as of the Effective Date, Section 9.1 of the Agreement is revised to add the following as Section 9.1.1:
  - 9.1.1 County shall pay to Huron a Subscription Fee of \$185,000 for the first Renewal Term; \$200,417 for the second Renewal Term; \$185,000 for the third Renewal

Term; \$213,000 for the fourth Renewal Term; and \$223,650 for the fifth Renewal Term.

4. All other terms and conditions of the Agreement, as amended, remain in full force and effect.
5. Execution and delivery of this Amendment by the parties shall be considered legally valid and effective if executed or adopted by a party through use of an electronic process (i.e., “electronic signature” through a process such as DocuSign®).

The undersigned parties agree to the terms and conditions of the above Amendment.
