RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF VENTURA
CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES
GRANT PROGRAMS

WHEREAS, the County of Ventura desires to participate in the grant programs listed in Exhibit 1 attached hereto, which are funded through and administered by the California Governor's Office of Emergency Services (the OES); and

WHEREAS, the OES, among other things, requires an applicant to obtain written authorization from the applicant's governing body to submit a grant proposal, accept grant funds, and execute any grant agreement pertaining to the grant programs;

NOW, THEREFORE, BE IT RESOLVED that the District Attorney of the County of Ventura is authorized on behalf of the Board of Supervisors to submit the grant proposals identified in Exhibit 1, to accept the grants, and to execute the grant agreements with the OES, including any extensions or amendments thereof, subject to review and approval by County Counsel.
