Subject: Approval of the Plans and Specifications for Pavement Resurfacing – Santa Rosa Valley Area project; Waive Any Minor Bid Irregularities; Award of, and Authorization for the Public Works Agency Director, or His Designee, to Execute a Contract with American Asphalt South, Inc. in the amount of \$2,170,013.48; Project Specification No. RD24-01, Project No. 50637; Supervisorial District No. 2

Discussion:

The purpose of this project is to resurface approximately 12.37 miles of deteriorated roadway on various roads in the Santa Rosa Valley area as shown on Vicinity Map (Exhibit 1), Location Map (Exhibit 2). Work will include roadway preparation, crack sealing, AC dike rehabilitation or seal, placing asphalt rubberized aggregate membrane (ARAM), placing Type II slurry seal on all the roads of the project, pavement delineation and striping, and appurtenant work. Funding for this project comes from Senate Bill 1, the Roads Maintenance and Rehabilitation Account.

No additional right-of-way is required for this project.

Bids for the project were opened on June 29, 2023. A copy of the abstract of bids received is attached (Exhibit 3). The lowest responsive bid was submitted by American Asphalt South, Inc. The low bid is 14% below the engineer's estimate of \$2,520,000.

On February 7, 2023, your Board previously declared the project categorically exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301 (c) because it consists of minor alterations of "existing highway and streets and will not have a significant effect on the environment, either individually or cumulatively".

A Notice of Exemption was filed on April 18, 2023.




The estimated total project costs are as follows:
