Subject: Approval of a Recommendation to Confirm the Appointment of Mike Sedell to the Ventura County Treasury Oversight Committee.

Recommendation:

It is recommended that your Board confirm the appointment of Mike Sedell to the Ventura County Treasury Oversight Committee ("Committee").

Fiscal Impact: None

Discussion:

The Committee was established on June 4, 1996, in accordance with the provisions of Government Code Sections 27131 et seq., which require that the Committee shall consist of from three to eleven members.

The Committee is currently comprised as follows:

- Pursuant to Government Code, Section 27132 (a), the County Treasurer, Sue Horgan.
- Pursuant to Government Code, Section 27132 (b), the County Auditor-Controller, Jeff Burgh.
- Pursuant to Government Code, Section 27132 (c), District 4 Supervisor, Janice Parvin, representing the Board of Supervisors.
- Pursuant to Government Code, Section 27132 (d), Deputy Superintendent Misty Key, representing the County Superintendent of Schools.

Mr. Mike Sedell is nominated to fill the seat pursuant to Government Code, Section 27132 (g), representing members of the public. Mr. Sedell served as City Manager for the City of Simi Valley for seventeen (17) years, retiring in 2012. Prior to that, Mr. Sedell served as Simi Valley's Assistant City Manager, Deputy City Manager, and other various City administrative positions for a combined thirty-seven (37) years. He also served as Chief of Staff to Congressman Elton Gallegly from 1986-1990. In 2013 he was appointed by the Ventura County Board of Supervisors to the Ventura County Employees' Retirement Association's Board of Retirement as a Trustee, serving ten (10) years, three (3) of which he was the Board Chair. Mr. Sedell also served as a Member of the Ventura County Health Clinic Oversight Board and the Board of Interface Children & Family Services. Currently, Mr. Sedell serves as the Treasurer and Finance Chair for the Museum of Ventura County. Mr. Sedell's experience in public administration will be valuable to the Treasury Oversight Committee, Ventura County.
