Subject: Approval of, and Authorization for the County Executive Officer, or Designee, to Sign Amendment No. 3 to Contract No. 9210 with Hanson Bridgett LLP Extending the Contract through October 31, 2026, Revising the Statement of Work, and Increasing the Not-To-Exceed Value by \$100,000 for a total amount of \$299,900.

Recommendation

It is recommended that your Board approve and authorize the County Executive Officer, or designee, to sign Amendment No. 3 to contract No. 9210 with Hanson Bridgett LLP (Hanson Bridgett) extending the contract through October 31, 2026, revising the Statement of Work, and increasing the Not-To-Exceed Value by \$100,000 for a total amount of \$299,900.

Discussion

CEO-Human Resources (CEO-HR) retained the law firm of Hanson Bridgett LLP (Hanson Bridgett) in 2023 to assist with the revision of several administrative policies to align them with industry best practices and to account for any updates to applicable California

employment laws, implementation of standardized operating procedures for the administrative investigation process, develop and provide additional training for County investigators, and conduct annual reviews of administrative investigations conducted by CEO-HR staff.

The proposed Amendment No. 3 (Exhibit 1) to Contract No. 9210, extends the contract through October 31, 2026, revises the Statement of Work to include workplace investigation services, and increases the Not-To-Exceed Value by \$100,000 from \$199,900 to \$299,900.
