Your Board annually awards Job Order Contracts (JOC), consistent with Public Contract Code section 20128.5, which allow the County to complete individual projects at County facilities involving the repair, remodeling, or other repetitive work to be done according to unit prices for typical work under the overall umbrella of the JOC. Individual projects under the JOC are priced by selecting the proper construction tasks and multiplying them by the correct quantity and

appropriate unit price. In accordance with Public Contract Code section 20128.5, no project shall be performed under these contracts except by order of your Board.


On 7/11/23, your Board approved a Job Order Contract with MTM Construction Inc for a total amount of \$5,967,000 for one year under ITB 6110. To date, approximately \$1,714,519.33 has been expended under the JOC on various individual projects at County facilities this year.

On 9/12/23, your Board approved a Job Order Contract with MTM Construction Inc for a total amount of \$5,967,000 for one year under ITB 6111. To date, approximately \$5,540,830.08 has been expended under the JOC on various individual projects at County facilities this year.

With this agenda item, the General Services Agency requests your Board's approval of, and authorization to perform, the anticipated individual projects listed in Exhibit 1 using the existing JOCs.
