- Provide a trend analysis of ED visits by Primary Diagnosis Body System for the most recent four years.
- Provide a trend analysis of ED visits by Primary Payer for the most recent four years.
- Provide a 5 year projection of population by zip code for the PSA.
- Provide a 5 year projection of population for each demographic cohort (sex, race, ethnicity and age group) for the PSA.
