

**FIRST AMENDMENT TO THE AGREEMENT
BETWEEN THE COUNTY OF VENTURA (COUNTY) AND
AURORA VISTA DEL MAR, LLC (CONTRACTOR)**

This "First Amendment" to the Agreement for Psychiatric Inpatient Hospital Services, which became effective July 1, 2022, is made and entered into by and between the **COUNTY OF VENTURA**, acting through its Behavioral Health Department, hereinafter referred to as "COUNTY," a primary service provider, and **AURORA VISTA DEL MAR, LLC**, hereinafter referred to as "CONTRACTOR":


NOW, THEREFORE, parties hereby agree that the Agreement is amended as follows:

- I. Effective with respect to the service period of July 1, 2022 through June 30, 2023, ARTICLE 4, (PAYMENT PROVISIONS), Subsection 4.1 (RATE STRUCTURE, CONTINGENT LIABILITY OF COUNTY/STATE), Section f, shall be revised to read as follows:
 - f) The maximum amount paid by COUNTY to CONTRACTOR for section 4.1.b shall be \$2,280,000 for the service period of July 1, 2022 through June 30, 2023.
- II. Except for the modifications described herein, all other terms and conditions of the Agreement, shall remain in effect.
- III. This First Amendment may be executed in counterparts, each of which shall constitute an original, and all of which taken together shall constitute one and the same instrument.
- IV. The parties hereto agree that this First Amendment may be transmitted and signed by electronic or digital means by either/any or both/all parties and that such signatures shall have the same force and effect as original signatures, in accordance with California Government Code Section 16.5 and California Civil Code Section 1633.7.
