CONCERNING ONE-TIME PAYMENTS FOR EMPLOYEES WHO DID NOT RECEIVE  
A TOTAL OF \$2,000 FROM THE CALIFORNIA STATE RETENTION BONUS UNDER  
LABOR CODE SECTION 1490 ET SEQ (SB184)**

**The County of Ventura ("County") and the Service Employees International Union, Local 721 ("SEIU") have agreed to the following:**

This agreement applies to employees covered by the 2022-2025 Memorandum of Agreement ("MOA") between the County and SEIU, who are 1) employed in designated health care classifications and listed in Exhibit 1 and who received a California State Retention Bonus under Labor Code section 1490 et seq. (SB184) but did not receive the full amount or 2) who were formerly employed as described above, listed in Exhibit 1, but have subsequently transferred or promoted to other classifications or County departments and who have maintained uninterrupted County service through the pay period ending in April 13, 2023.


Effective with the pay period beginning March 31, 2024, employees who are covered by the MOA on the date of adoption, listed in Exhibit 1 and who did not receive the full benefit from the California State Retention Bonus under Labor Code section 1490 et seq. (SB184) shall receive a one-time payment of \$250.
