HEARING

The Fiscal Year (FY) 2024-25 Preliminary Budget for the County of Ventura, State of California General Fund, Fire Protection District, Watershed Protection District, Waterworks and Sanitation Operations, County Service Areas, and all other Non-General Funds, has been submitted to the Ventura County Board of Supervisors.

The Final Budget Hearing will begin on Monday, June 17, 2024, at 5:00 p.m., and may be continued from day to day thereafter, as necessary, until the FY 2024-25 Budget is adopted. The hearing will also include, in conjunction with the consideration of the budget for the Ventura County Medical Center (VCMC) Enterprise Fund, consideration of the VCMC Charge Description Master ("Chargemaster"), which establishes prices and charges for hospital services at County hospitals. The public hearing will be held in the Board of Supervisors Hearing Room in the Hall of Administration, Ventura County Government Center, 800 South Victoria Avenue, Ventura, California.
