**Sergeant Jason Cantrall**  
**Ventura County Sheriff's Office**  
**34 Years of Public Service**

*Whereas, Jason Cantrall began his career with the Ventura County Sheriff's Office on March 25, 1990. Jason was hired as a Cadet and was assigned to the East County Patrol Station -Thousand Oaks Traffic Bureau; and*

*Whereas, Jason completed the Ventura County Police and Sheriff's Reserve Academy and was hired as a Reserve Deputy Sheriff on April 29, 1992; and*

*Whereas, Jason entered the Orange County Sheriff's Academy Class #119 and graduated February 22, 1995. Jason was assigned to the Orange County Sheriff's Men's Central Jail and worked in this assignment until September 1995 where he laterally transferred to the Ventura County Sheriff's Office; and*

*Whereas, Jason was hired by the Ventura County Sheriff's Office on October 8, 1995 where he was assigned to the Todd Road Jail Facility. Jason was later transferred to the East County Patrol Station assigned as a Patrol Deputy. Jason excelled in patrol and was selected as a Field Training Officer training numerous deputies at the East County Patrol Station. Jason was recognized for his hard work and dedication and was awarded Officer of the Year in 2002. Jason was then assigned to the Thousand Oaks Special Enforcement/Gang Unit in 2004; and*

*Whereas, in April 2007, Jason was promoted to the rank of Senior Deputy and worked as a supervisor at the Pre-Trial Detention Facility and East County Jail Facility. Jason later transferred to the Headquarters Patrol Station where his tenacity and work ethic was again recognized and was awarded Officer of the Year in 2011; and*

*Whereas, Jason was assigned to the Ventura County Sheriff's Narcotics Bureau in 2011 and was assigned to the East County Street Team and Ventura County Combined Agency Team (VCAT). During this tenure of almost 7 years, Jason began working with his K-9 Partner Chase specializing in vehicle and parcel interdiction seizing many pounds of narcotics and over 2 million dollars. Jason's team worked on 2 major Human Trafficking Rings targeting Ventura County that led to arrests of the ring leaders of these operations after hundreds of hours of surveillance and investigation; and*

*Whereas, in October 2017, Jason was promoted to the rank of Sergeant and was assigned to the Pre-Trial Detention Facility. Jason was later transferred to the Camarillo Patrol Station. While as a Patrol Sergeant, Jason continued his dedication to training by being assigned as the Field Training Sergeant for the Camarillo Patrol Station.*

*Whereas, in November 2020, Jason was selected to the Ventura County Sheriff's Major Crimes Bureau to supervise the Financial Crimes Unit. Jason and his team completed many complex fraud investigations which were submitted to the District Attorney's Office and prosecuted. Jason has been an instrumental part in homicide investigations by analyzing and documenting homicide crime scenes to ensure all evidence is collected, properly handled, and the scene is clearly documented; and*






