RECOMMENDATION:

That your Board approve, and authorize the Health Care Agency (HCA) Director or designee to sign, on behalf of the Ventura County Health Care Plan (VCHCP), the Third Amendment to the Hospital Services Agreement with Dignity Health, d/b/a, St. John's Regional Medical Center and St. John's Hospital Camarillo (Dignity Health), which extends the agreement through August 31, 2026 and adds a new compensation for services exhibit, effective September 1, 2023.

DISCUSSION:

The Ventura County Health Care Plan (VCHCP) has contracts with the Ventura County Medical Center (VCMC) and non-VCMC health care providers to obtain elective, emergency, and specialized patient care services. These contracts are needed to deliver adequate medical services to VCHCP enrollees and to ensure geographical and timely access.

If approved by your Board, the Third Amendment to the hospital services agreement with Dignity Health will extend the Agreement through August 31, 2026 and add a new compensation for services exhibit, effective September 1, 2023. The compensation rates and stop-loss thresholds will increase by 4% for year 1, year 2 and year 3. On July 11, 2023 your Board approved expenditures for this contract for FY 23-24 in the total amount of \$4,500,000. At this time, there is no anticipated need for an increase in expenditures or appropriations.

The rate information for this agreement is exempt from disclosure under the Public Records Act (Gov. Code, Section 7926.205) and is redacted in the attached exhibit. An unredacted copy is available to Board members on request.


