On October 8th, I sent the BoS a communication with a significant number of reports dealing with the insecurity of electronic election systems. In fact, I would say that the threat is so high that these machines should be categorized as a national security threat. Let me highlight some of the more powerful points I made two weeks ago before, introducing the latest bombshell report on the subject, the existence of a criminal gang in Venezuela that is behind the entire election rigging scheme. This election rigging scheme has been conducted by this criminal gang in 70 different countries, including the US, over the past 20 years.

A sampling of evidence of election fraud:

1. The HBO documentaries, "Hacking Democracy" (2005) and "Kill Chain: The Cyber Attack on America's Elections" (2020), show how easy it is to hack a computerized election system. Both are now available to view on streaming services like Amazon.
2. In the 2020 election cycle, Antrim County MI reported early on that they had found a "mistake" in which 6000 Trump votes were miraculously flipped to Biden. In the ensuing investigation, the cyber forensic examiner concluded that the machines were designed to rig elections. However, Dr. Byrne has uncovered another occurrence during the 2020 election that produced, perhaps, up to 10 million counterfeit ballots (all for Biden) that were shipped to key battleground states to stuff ballot boxes to assure a comfortable 2020 election victory for Biden. **CONCLUSION:** The hasty, covert agreement to extend the contract for Dominion voting systems 9 more years made on 8 Dec 24 will enable a criminal enterprise to continue

operating in Ventura County.

RECOMMENDATIONS: (1) Since Smartmatic, the operating system of all three electronic voting systems, has shown its willingness to rig elections, the Ventura County BoS should terminate the current Dominion contract as an untrustworthy solution for elections.

(2) Following termination of the Dominion contract, the county should return to the proven election system that uses paper ballots, hand counted by citizen volunteers, with the use of a valid form of photo identification. Such a system is far less expensive, more reliable, and cannot be hacked by any domestic or foreign entity.
