Report Describing Sewer Service Charges and Sewer Standby Charges for Each
Parcel for FY 2023-24 (Health and Safety Code Section 5473)

Ventura County Waterworks District No. 16 (WWD 16) provides sewer service to the community of Piru. Piru is an underserved community, and staff is continuously monitoring the expenditures to minimize the financial impact on its residents. All management, administrative, budgetary, and operations and maintenance (O&M) functions are accomplished by the Public Works Agency Water and Sanitation Department on behalf of WWD 16.

WWD No. 16 collects sewer charges on the general County tax roll as provided in Section 5473.

TOTAL SERVICE CHARGES REQUIRED

The proposed sanitation O&M requirements and financing for FY 2023-24 are as follows:

Total requirements for sanitation O&M in FY 2023-24 are \$1,640,900. The total sewer service charges proposed are \$1,071,219, to be levied at a rate of \$109.55 per month per Residential Unit Equivalent (RUE), at a 5% percent increase compared to FY 22-23. It is also proposed that the sewer standby charge remain unchanged at \$46.82 per parcel, resulting in an additional \$6,461 in revenue.

A summary showing the total amount of sewer service charges and sewer standby charges is shown on the attached "Summary of Sewer Service Charges and Sewer Standby Charges for FY 2023-24" (Exhibit 3A). A schedule listing by Assessor's Parcel Number (APN) the proposed amount of sewer service charges or standby charges applicable to each parcel is shown on the attached "Schedule of Sewer Service Charges

and Sewer Standby Charges for FY 2023-24" (Exhibit 3B). Said parcels are also depicted on a set of maps in the County Surveyor's Office.

This report is being filed with you pursuant to Section 5473 of the Health and Safety Code.
