WHEREAS, 2025 MARKS THE 50TH ANNIVERSARY OF SENIOR CONCERNS, A MILESTONE REFLECTING ITS UNWAVERING COMMITMENT TO ENHANCING THE HEALTH, WELL-BEING, AND QUALITY OF LIFE FOR SENIORS AND FAMILY CAREGIVERS IN THE CONEJO VALLEY; AND

WHEREAS, FOR HALF A CENTURY, SENIOR CONCERNS HAS BEEN DEDICATED TO CREATING A COMMUNITY WHERE SENIORS THRIVE, CONTINUOUSLY EVOLVING TO MEET THE CHANGING NEEDS OF OLDER ADULTS AND THEIR CAREGIVERS BY PROVIDING VITAL RESOURCES, ADVOCACY, AND A FOUNDATION OF SUPPORT; AND

WHEREAS, EACH YEAR SENIOR CONCERNS SERVES 13,000 SENIORS THROUGH ESSENTIAL PROGRAMS SUCH AS MEALS ON WHEELS/HOME DELIVERED MEALS, DELIVERING OVER 65,000 MEALS ANNUALLY TO 450 HOMEBOUND SENIORS, AND ITS ADULT DAY CENTER, WHICH PROVIDES OVER 20,495 HOURS OF CARE TO 120 SENIORS WHILE OFFERING RESPITE TO 240 CAREGIVERS; AND

WHEREAS, SENIOR CONCERNS SERVES AS THE CENTRAL RESOURCE FOR SENIORS AND CAREGIVERS IN EASTERN VENTURA COUNTY, FIELDING OVER 10,000 INQUIRIES ANNUALLY AND OFFERING CRITICAL SERVICES SUCH AS HOUSING RIGHTS ADVOCACY, LOW-INCOME OPTIONS, MEAL SERVICES, AND DEMENTIA CARE EDUCATION THROUGH ITS CAREGIVER RESOURCE CENTER; AND

WHEREAS, SENIOR CONCERNS PROVIDES SEMINARS AND WORKSHOPS TO OVER 500 SENIORS ANNUALLY, AND ITS LEADERSHIP CONTRIBUTES REGULARLY TO COMMUNITY EDUCATION ADDRESSING ISSUES AFFECTING SENIORS AND CAREGIVERS; AND

WHEREAS, THE EFFORTS OF SENIOR CONCERNS ARE POWERED BY 440 VOLUNTEERS WHO CONTRIBUTE MORE THAN 10,700 HOURS OF SERVICE ANNUALLY, ALONGSIDE GENEROUS PHILANTHROPIC SUPPORT FROM THE COMMUNITY, ENSURING A LEGACY OF CARE AND COMPASSION;

NOW, THEREFORE, THE VENTURA COUNTY BOARD OF SUPERVISORS, DO HEREBY RECOGNIZE SENIOR CONCERNS' 50TH ANNIVERSARY AND COMMEND ITS EXTRAORDINARY SERVICE TO SENIORS AND CAREGIVERS, CELEBRATING ITS PAST ACHIEVEMENTS AND REAFFIRMING ITS ESSENTIAL ROLE IN BUILDING A BRIGHTER FUTURE FOR THE AGING COMMUNITY.
