* Note: Consistent with Government Code provisions, the Ventura LAFCO, effective January 1, 2002, established that all terms will expire on January 1 rather than the first Monday of May, and extended all terms expiring in May to January 1 of the following year.

** Amendment to Commissioner's Handbook Chapter 1 (By-Laws) of Division 1 (Operational Rules & Regulations) effective May 20, 2020: The inauguration date of the term of office shall be January 1 in the year in which the term of the member begins, and the expiration date of the term of office shall be December 31 in the year in which the term of the member expires.
