**SUBJECT:** Authorization for the County Executive Officer or Designee to Receive, Accept and Upon Review and Approval of County Counsel, Execute Three Agreements with the U.S. Department of Housing and Urban Development for Continuum of Care Grant Funds Totaling \$507,218; and Authorization for the Auditor Controller to Process the Accounting Transactions Necessary to Establish Appropriations and Revenues. (RECOMMENDATION NO. 2 REQUIRES 4/5THS VOTE).

## RECOMMENDATIONS:

1. Authorize the County Executive Officer or designee to receive, accept and, upon review and approval of County Counsel, execute three agreements with the U.S. Department of Housing and Urban Development (HUD) for Continuum of Care (CoC) grant funds totaling \$507,218.
2. Authorize the Auditor-Controller to process the accounting transactions necessary to establish appropriations and revenue for the CoC Program

**VENTURA COUNTY STRATEGIC PLAN:**

**Strategic Priority:**

- Address Homelessness and Lift Up the Most Vulnerable

The recommendations support the creation and maintenance of programs that serve persons experiencing homelessness and lift up the most vulnerable in our community.

**DISCUSSION:**

HUD's CoC Program includes an annual competitive grant program designed to promote communitywide commitment. Its goals are to end homelessness; provide funding for efforts by nonprofit providers, and state and local governments to quickly rehouse homeless individuals and families while minimizing the trauma and dislocation caused to homeless individuals, families, and communities by homelessness; promote access to and effect


utilization of mainstream programs by homeless individuals and families; and optimize self-sufficiency among individuals and families experiencing homelessness. Approximately \$3.7 million is awarded to entities within Ventura County annually. Local awards are recommended to HUD by the Ventura County CoC Board.

As the Collaborative Applicant for CoC funding on behalf of the Ventura County CoC, the County Executive Office (CEO) applied for and seeks your Board's authority to receive and accept \$507,218 of the \$3.7 million in 2024 CoC grant funding, which the CEO will then administer. The balance of CoC funds are contracted by HUD directly with local organizations to carry out activities serving homeless persons in our county. The CoC funds administered by the CEO include two grants for Rapid Re-Housing services, one to Lutheran Social Services (\$223,295) and another to Salvation Army (\$58,842). The balance (\$225,081) is a Planning Grant – funds to be used to enhance performance of the CoC homeless service system and incorporate people with lived experience in the strategic planning and decision-making process.

It is recommended that the CEO or her designee, upon review and approval of County Counsel, be authorized to execute the three agreements with the U.S. Department of Housing and Urban Development (HUD), and for the Auditor-Controller to process the accounting transactions necessary to establish appropriations and revenues for the CoC grant funds.
