

NINTH AMENDMENT TO  
COUNTY OF VENTURA CONTRACT

BETWEEN THE COUNTY OF VENTURA AND  
CROTHALL LAUNDRY SERVICES  
INC.

This Ninth Amendment dated August 10, 2023, is entered into by and between THE COUNTY OF VENTURA (hereinafter referred to as “County”), and CROTHALL LAUNDRY SERVICES INC., a Delaware corporation with its principal office located at 8936 NorthPointe Executive Park Drive, Suite 100, Huntersville, NC 28078 (hereinafter referred to as “Contractor”).

**WITNESSETH**

WHEREAS, County entered into County of Ventura Contract #7249 with Contractor dated November 1, 2015 and amended February 1, 2016, September 1, 2017, November 1, 2020, June 22, 2021, October 22, 2021, April 1, 2022, September 22, 2022, and March 1, 2023 (hereinafter collectively referred to as the “Agreement”); and

WHEREAS, the parties desire to make certain alterations, additions or deletions to the Agreement, effective as of August 10, 2023.

NOW, THEREFORE, in consideration of the promises and mutual covenants herein contained, and intending to be legally bound hereby, the parties agree as follows:

1. The term of the Agreement is extended through October 31, 2024.
2. The Contract not-to-exceed amount is increased to \$8,078,823.
3. The section of Exhibit A entitled Contractor Responsibilities, is hereby amended such that the table identifying the locations is amended to include the clinic locations on the attached Contractor Responsibilities Clinic Location Table dated August 10, 2023 (collectively, the “Clinic Locations”).

All other terms, conditions and stipulations contained in the Agreement shall remain in full force and effect and without any change or modification whatsoever, except that in the event of any conflict between this Amendment and the Agreement, this Amendment will control. Unless otherwise defined herein, all capitalized terms shall have the meanings ascribed in the Agreement. This Amendment may be executed in one or more counterparts. Each counterpart shall be deemed an original, but all counterparts together constitute one and the same instrument.
