**BEGINNING** AT THE SOUTHEAST CORNER OF SAID LAND DESCRIBED IN BOOK 5363, PAGE 398 OF OFFICIAL RECORDS, ALSO BEING THE SOUTHWEST CORNER OF LOT G OF TRACT 6061 AS SHOWN ON THE MAP RECORDED IN BOOK , PAGE OF MISCELLANEOUS RECORDS (MAPS), IN THE OFFICE OF SAID COUNTY RECORDER; THENCE NORTHERLY ALONG THE EASTERLY LINE OF SAID LAND DESCRIBED IN BOOK 5363, PAGE 398 OF OFFICIAL RECORDS, NORTH 194.75 FEET TO THE SOUTHERLY MOST LINE OF THE PROPOSED EASEMENT FOR SEWER AND WATER AS SHOWN IN HE SAID LOT G OF TRACT NO. 6061 BEING THE **TRUE POINT OF BEGINNING**; THENCE LEAVING SAID EASTERLY LINE, ALONG THE WESTERLY PROLONGATION OF SAID SOUTHERLY MOST LINE

**1<sup>st</sup>:** WEST 106.97 FEET; THENCE

**2<sup>nd</sup>:** NORTH 40°00'00" WEST 46.33 FEET TO THE SOUTHEASTERLY LINE OF ELDERBERRY AVENUE AS SHOWN ON TRACT NO. 3841-2 RECORDED IN BOOK 95, PAGE 21 OF MISCELLANEOUS RECORDS (MAPS) ALSO BEING THE BEGINNING OF A NON-TANGENT CURVE CONCAVE NORTHWESTERLY HAVING A RADIUS OF 84.50 FEET, A RADIAL LINE THROUGH SAID POINT BEARS NORTH 28°39'36" WEST; THENCE ALONG SAID SOUTHEASTERLY LINE

**3<sup>RD</sup>:** NORTHEASTERLY THROUGH A CENTRAL ANGLE OF 20°27'14" AN ARC LENGTH OF 30.17 FEET TO A POINT ON A LINE PARALLEL WITH AND 30.00 FEET NORTHEASTERLY OF THE 2<sup>ND</sup> COURSE DESCRIBED HEREIN, RADIAL LINE TO SAID LAST MENTIONED POINT ON SAID CURVE BEARS NORTH 49°06'51" WEST; THENCE NON-TANGENT TO SAID CURVE, LEAVING SAID SOUTHEASTERLY LINE ALONG SAID PARALLEL LINE

**4<sup>TH</sup>:** SOUTH 40°00'00" EAST 31.76 FEET TO A LINE PARALLEL WITH AND 30.00 FEET NORTHERLY OF THE 1<sup>ST</sup> COURSE DESCRIBED HEREIN; THENCE ALONG LAST SAID PARALLEL LINE

**5<sup>TH</sup>:** EAST 92.98 FEET TO SAID EASTERLY LINE OF LAND DESCRIBED IN BOOK 5363, PAGE 398 OF OFFICIAL RECORDS; THENCE ALONG SAID EASTERLY LINE
