CONTRACT AMENDMENT

**FIFTH AMENDMENT TO VENTURA COUNTY CONTRACT# 6590 BETWEEN
COUNTY OF VENTURA AND MOTOROLA SOLUTIONS, INC.**

WHEREAS Motorola Solutions, Inc. ("MSI") and the County of Ventura ("County") entered into Ventura County Contract # 6590 ("Contract") dated July 31, 2012, for Maintenance and Support Services for County Simulcast Radio Systems;

WHEREAS, MSI and County amended the Contract on June 20, 2017, to extend the terms of the Contract from July 1, 2017, through December 31, 2019;

WHEREAS, MSI and County have extended the Contract term through October 31, 2021, via Amendment No. 2;

WHEREAS, MSI and County have extended the Contract term through December 31, 2022, via Amendment No. 3;

WHEREAS, MSI and County have extended the Contract term through December 31, 2023, via Amendment No. 4; and

WHEREAS, MSI and County would like to extend the term of the contract from January 1, 2024 through December 31, 2024.

NOW THEREFORE, the parties hereto agree as follows:

1. Contract Term. Section 4 of the Contract is amended to extend the term of the Contract from January 1, 2024, through December 31, 2024.
2. MSI will perform the services for the prices as set forth in MSI's Service Agreement dated September 2, 2023, USC000008491 (Sheriff), and Service Agreement dated September 2, 2023, USC000006746 (Fire) attached hereto collectively as Exhibit B-1.
3. Except as specifically modified by this Fifth Amendment and Exhibit B-1, all other terms and conditions of the Contract shall remain in full force and effect as originally executed.
4. The parties hereto agree that this Fifth Amendment may be transmitted and signed by electronic or digital means by either/any or both/all parties and that such signatures shall have the same force and effect as original signatures, in accordance with California Government Code Section 16.5 and California Civil Code Section 1633.7.
