**RESOLUTION OF THE  
BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA  
CONCERNING CLASSIFICATIONS AND SALARY RANGES  
PURSUANT TO SECTIONS 908 AND 2701 OF THE
