

**AMENDMENT NO. 1 TO CONTRACT BETWEEN COUNTY OF VENTURA AND FRONTIER
ENERGY INC.**

This "Amendment No. 1" is entered into by and between the COUNTY OF VENTURA ("County") and FRONTIER ENERGY INC., ("Contractor"), as of the last date written below, to amend that certain contract between County and Contractor dated July 12, 2022 for services related to the administration of the Tri-County Regional Energy Network's (3C-REN) Single-Family Home Energy Savings and Commercial Energy Savings Programs ("Contract").

NOW, THEREFORE, the parties hereby agree as follows:


1. The first sentence of Section 5 of the Contract is amended to read as follows:

*This Contract will be in effect from July 12, 2022, through December 31, 2025,
subject to all the terms and conditions set forth herein.*


2. "Exhibit A" to the Contract is replaced with and superseded in its entirety by new "Exhibit A," attached hereto.
3. All provisions of the Contract shall remain in full force and affect unless expressly modified by this Amendment.
4. This Amendment No. 1 may be executed in counterparts, each of which shall constitute an original, and all of which taken together shall constitute one and the same instrument.
