**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA
AUTHORIZING THE VENTURA COUNTY SHERIFF'S OFFICE TO ACCEPT THE
ORGANIZED RETAIL THEFT PREVENTION GRANT PROGRAM FUNDING FROM THE
CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS AND
ESTABLISHMENT OF FIXED TERM AND FULL TIME REGULAR ALLOCATION
POSITIONS PURSUANT TO SECTION 903 OF THE PERSONNEL RULES AND
REGULATIONS**

WHEREAS, the Ventura County Sheriff's Office desires to accept grant funding through the Organized Retail Theft Prevention Grant from the California Board of State and Community Corrections, for the award period of October 1, 2023, through June 1, 2027, and intends to use the funds from the grant to enable the County of Ventura, the Ventura County Sheriff's Office, local law enforcement agencies, and other collaborative partners to continue a county-wide anti-theft project known as Ventura County Organized Retail Theft Task Force.

WHEREAS, as part of funding acceptance, the California Board of State and Community Corrections recommends, among other things, a resolution of an applicant's governing body that the applicant is authorized to accept grant funding.

WHEREAS, Section 903 of the Ventura County Personnel Rules and Regulations requires that the number of positions and classification of such positions within departments shall be established by resolution of the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED, the following Fixed Term Positions from October 1, 2023 through December 31, 2026 are established in the Sheriff's Special Services Division.
