Re: Extension of Letter of Agreement for Acute Care Pediatric Services

Dear Paul:

As you are aware, County of Ventura, as the owner and operator of Ventura County Medical Center (“Provider”), and Kaiser Foundation Hospitals, on behalf of its Southern California region, entered into a Letter of Agreement, effective as of October 1, 2023 (the “LOA”) pending possible completion of negotiations for a more comprehensive health care services agreement between the parties. While the parties’ discussions are ongoing, negotiations have not been finalized.

The current extension term of the LOA is effective through August 31, 2024. By this letter (this “Third Extension Letter”), the parties hereby agree to extend the term and mutual covenants and agreements contained in the LOA for an additional period of four (4) months, from September 01, 2024 through December 31, 2024 (the “Extension Period”). All other terms and conditions of the LOA shall remain in full force and effect during the Extension Period unless an earlier date is agreed to in writing by the parties for the implementation of Health Care Services Agreement.
