APRIL 30TH 2024
NATIONAL THERAPY ANIMAL DAY IN VENTURA COUNTY

WHEREAS, PET PARTNERS HAS DESIGNATED APRIL 30 AS NATIONAL THERAPY ANIMAL DAY, CREATED TO RECOGNIZE AND HONOR THERAPY DOGS AND OTHER THERAPY ANIMALS WHO PARTNER WITH THEIR HUMAN COMPANIONS (HANDLERS) TO BRING COMFORT AND HEALING TO THOSE IN NEED; AND

WHEREAS, THERE ARE THOUSANDS OF PET PARTNERS THERAPY ANIMAL TEAMS SERVING IN COMMUNITIES ACROSS THE UNITED STATES, WHO VOLUNTEER THEIR TIME AND COMPASSION DURING VISITS IN A VARIETY OF SETTINGS INCLUDING HOSPITALS, PEDIATRIC CARE UNITS, SCHOOLS, AND ASSISTED LIVING FACILITIES; AND

WHEREAS, SCIENTIFIC RESEARCH SHOWS THAT INTERACTING WITH THERAPY ANIMALS CAN REDUCE STRESS, RELIEVE DEPRESSION, SLOW HEART RATE, LOWER BLOOD PRESSURE AND STRENGTHEN THE IMMUNE SYSTEM; AND

WHEREAS, THERAPY ANIMAL TEAMS IN VENTURA COUNTY PLAY AN ESSENTIAL ROLE IN IMPROVING HUMAN HEALTH AND WELL-BEING THROUGH THE HUMAN-ANIMAL BOND; AND

WHEREAS, THERAPY ANIMAL TEAMS INTERACT WITH A VARIETY OF PEOPLE IN OUR COMMUNITY INCLUDING VETERANS, SENIORS, PATIENTS, STUDENTS, AND THOSE APPROACHING END OF LIFE; AND


