POST-ADOPTION SUMMARY OF ORDINANCE 366 OF THE COUNTY OF VENTURA AMENDING DIVISION 2, CHAPTER 3, SECTIONS 2800 THROUGH 2811 OF THE VENTURA COUNTY ORDINANCE CODE REGARDING SIDEWALK VENDING REGULATIONS

The following is a summary of an ordinance adopted by the Ventura County Board of Supervisors on September 10, 2024.

The ordinance makes the following changes to the County of Ventura's Sidewalk Vending Ordinance, which is codified in Division 2, Chapter 3, Sections 2800 through 2811 of the Ventura County Ordinance Code:

- Amends Section 2810 to change the term "notice of violation" to "administrative citation."

- Amends Sections 2805, 2810 and 2811 to change the administrative appeal process to written appeal format, and to provide an additional right to administratively appeal every administrative citation.

- Amends Section 2811 to reduce from 90 days to 30 days the amount of time before impounded and unclaimed vending equipment will be considered abandoned and forfeited.

The ordinance was adopted by the following vote:
