**SUMMARY OF PROPOSED
ORDINANCE OF THE
COUNTY OF VENTURA
REPEALING AND REEN-
ACTING PARTS OF ORDI-
NANCES 4610 AND 4399
REGARDING THE OFFICE
OF PUBLIC GUARDIAN
AND OFFICE OF PUBLIC
ADMINISTRATOR**

The following is a summary of a proposed ordinance to be considered for adoption by the Ventura County Board of Supervisors at a public meeting on Tuesday, January 9, 2024, at 10:30 AM in the Board of Supervisors Hearing Room in the Hall of Administration at the Ventura County Government Center, 800 S. Victoria Avenue, Ventura, California.

SUMMARY OF PROPOSED ORDINANCE: The proposed ordinance makes changes to two existing Ordinances - Ordinance 4399 (adopted 2009) and Ordinance 4610 (adopted 2002) - relating to the Offices of the Public Guardian and Public Administrator:

- Section 5 of Ordinance 4399 will be repealed and revised to provide that the office of the Public Guardian (PG) will be separate from the office of the Public Administrator and to provide that the County's Chief Executive Officer with the concurrence of the Board of Supervisors will appoint the PG.

- Two sections of Ordinance 4610 as reenacted in 2022 will also be repealed and replaced. A reference to the "Area Agency on Aging" (AAA) will be removed from the list in section 6, subdivision b. Personnel, subdivision 1) of department heads appointed by the County Executive Officer, to reflect a new County reporting structure already in place that places selection and oversight of the AAA Director within the scope of the Human Services Agency Director. Section 6, subdivision b. Personnel, subdivision 2) will be reorganized to reflect the separation of the roles of public administrator and public guardian.
