Make the following modifications to the bidding documents for the subject project:

1. Replace the Table of Contents with the attached revised Table of Contents.
2. Replace the Project Information with the attached revised Project Information.
3. Delete Sheet 61 Control Room Electrical Plans.
4. Add Sheet 61-A Control Room Electrical Plans.
5. Add Sheet 61-B Control Room Electrical Plans.
6. Add Sheet 61-C Control Room Electrical Plans.
7. Add Sheet 61-D Control Room Electrical Plans.
8. Add Sheet 61-E Control Room Electrical Plans.
9. Replace Sub-Section 1000-26 of the Specifications with the following language:

1000-26 STAGING AREAS

The Contractor shall arrange and maintain secure storage and staging sites at two locations shown on revised EXHIBIT A.

The District **could not** secure a temporary easement permit from the City of Oxnard to use the City of Oxnard storage site next to the maintenance yard known as the Dallas Cowboys parking lot. The Contractor may directly approach the City of Oxnard to inquire for permission to use the site. The storage and staging sites, temporary fencing and gates are the responsibility of the Contractor as part of Section 1000, and the Contractor will not be compensated for these two items.

The Contractor shall coordinate closely with the City of Oxnard during each year of construction for specific dates when the Dallas Cowboys conducts its annual Training Camp, which is well attended by the public and to ensure there are no construction conflicts during construction of the floodwalls and floodgate with the annual Dallas Cowboys Training Camp and public access thereto. All deliveries of materials to the job site shall be planned and executed so that traffic at N. Ventura Road is not obstructed or interfered with in any fashion during this time.

The Contractor shall not use the area between N. Ventura Road and the adjacent residential block wall southeast of N. Ventura Road, which contains the existing multi-use path serving the residential community, as a storage and staging site.

10. Replace EXHIBIT A of the Specifications with the attached REVISED EXHIBIT A.
11. Replace call out note on Sheet 9 of 62 of the Construction Plans stating “4-inch soft bend conduit for electrical connection” with the following statement: “Penetrations with 4-inch soft bend conduits for HPU unit hydraulic lines for both gates per detail AAA on sheet 31. The locations of penetrations can be revised in the field per manufacture recommendations.”
12. Replace call out notes on Sheet 30 of 62 of the Construction Plans stating “electrical penetration 4” soft bend conduit from HPU unit to the gate (TYP)” with the following statement: “Penetration with 4-inch soft bend conduit for HPU unit hydraulic lines per detail AAA on sheet 31. The locations of penetration can be revised in the field per manufacture recommendations.”
13. Revise 1013-3.1.1, Placing, delete “If required” from beginning of the second paragraph.
14. Add the following to the end of subsection 1042-1, SCOPE.
 3. Make connections from Mission Communications M 150 Cellular – based RTU shown under subsection 1015-2.5, External Electronics, to both floodgates and utility room entrance door via one inch conduit and wiring shown on the Control Room Electrical Plans. The connection to entrance door is not shown on Control Room Electrical Plans but it is part of section 1042 and Contractor shall connect the front door to the Mission Communications M 150 Cellular system.

Acknowledgment of this addendum is required on the Bonfire website when submitting your bid. Failure to do so may result in the disqualification of your bid.
