**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF VENTURA TO  
CONTINUE EXISTING SERVICE CHARGES FOR COUNTY SERVICE AREA NO. 4 FOR  
FISCAL YEAR 2024-25**

**WHEREAS**, the Board of Supervisors of the County of Ventura (Board), acting as governing authority for County Service Area (CSA) No. 4, previously fixed charges for extended services for CSA No. 4 pursuant to County Ordinance No. 3428 which was enacted pursuant to Government Code section 25210.7~~7~~<sup>a</sup> and given continuing effect through Government Code section 25210.3(d); and

**WHEREAS**, a report pursuant to County Ordinance No. 3428 entitled "County Service Area No. 4 Report Fixing Charges for Fiscal Year 2024-2025" (Report), attached hereto as Exhibit 1, is on file with the Clerk of the Board;

**WHEREAS**, the Report includes a "Vicinity Map CSA 4" (Exhibit 2), "Area Map CSA 4" (Exhibit 3) and "County Service Area No. 4 Schedule of Charges for Fiscal Year 2024-25" (Exhibit 4) and sets forth charges in Exhibit 4 that do not exceed the estimated reasonable cost of providing the services;

**WHEREAS**, the assessment rates and methodology proposed for fiscal year (FY) 2024-25 set forth in the Report remain unchanged since FY 1996-97 and are therefore exempt from the notice and protest provisions of Proposition 218;

**WHEREAS**, notice of the proposed action has been provided in accordance with law;

**WHEREAS**, the Board conducted a public hearing on June 18, 2024 to hear and consider all oral and written comments, protests and objections concerning the proposed action;

**WHEREAS**, the Board has considered all oral and written comments, protests and protests, if any, made regarding the proposed action; and

**WHEREAS**, section 5-4 of County Ordinance No. 3428 authorizes collection of these charges at the same time and in the same manner as general County property taxes (with the exception of the parcels which are billed manually);

**NOW, THEREFORE, BE IT RESOLVED** that the Board approves the Report, and the charges described therein, and approves the continued collection of the charges described in the Report as part of the annual general County tax roll for FY 2024-25.
