RE: WARN Notice due to employment loss at Southern California Pizza Company LLC, SoCal South OC LLC and SoCal Pizza Holdings, LLC

This letter is being sent to you by Southern California Pizza Company LLC, SoCal South OC LLC and SoCal Pizza Holdings, LLC (collectively, the "Company") to provide notice that, due to the discontinuation of direct delivery services at the Company, the Company's operations located at the addresses listed in Exhibit A¹ attached hereto will unfortunately need to conduct layoffs due to the elimination of all delivery driver jobs due the discontinuation of delivery services. This will result in the anticipated layoff of approximately 841 employees. We anticipate the layoffs that are the subject of this notice to begin on or around February 5, 2024, and further layoffs may continue for the subsequent week. We are providing this notice based on the best information known to us at this time.

All of the layoffs will be of individuals in the job title of "delivery driver", and all employees employed solely in the position of "delivery driver" at the locations listed in Exhibit "A" will be laid off. Exhibit "A" contains the number of delivery driver positions which will be eliminated at each location. The anticipated schedule for the layoffs at each location is for layoffs to occur on February 5, 2024. All the delivery driver position layoffs at each location are anticipated to occur on the indicated date.

The affected individuals have been sent a similar notice. A template copy of the notices sent to the affected employees is enclosed as Exhibit "B" for additional information.

The job titles of positions and classifications to be affected (which in this case is all employees that work exclusively as a "delivery driver") and the number of affected employees in each location are attached. There are no bumping rights associated with this layoff, which is intended to be permanent given the complete discontinuation of direct delivery services.

There are no unionized employees at the Company and therefore no union representatives.

¹ Please note that because some of the delivery drivers provide delivery driver services to the Company at more than one of the Company's service locations and/or entities, and out of an abundance of caution, Southern California Pizza Company, SoCal South OC, and SoCal Pizza Holdings are providing notice for their combined locations for purposes of this WARN notice only. Providing this notice should not be taken as and is not intended as any admission or concession regarding an entity relation or joint employer/unity of enterprise relationship between any of the individual locations or entities listed herein.
