Subject: **Adoption of a Resolution Designating By Position the Sheriff, Assistant Sheriff, or the Director of Sheriff Emergency Services as agents of the County of Ventura Authorized to Execute Documents Submitted to the California Governor's Office of Emergency Services and the Federal Emergency Management Agency to obtain Disaster Recovery Funds**

Recommendations:

Adopt the attached Resolution (Exhibit 1) designating by position the Sheriff, Assistant Sheriff, or the Director of Sheriff Emergency Services as agents of the County of Ventura authorized to execute documents submitted to the California Governor's Office of Emergency Services (Cal OES) and the Federal Emergency Management Agency (FEMA) to obtain disaster recovery funds.

Fiscal Impacts:

There is no fiscal impact.

Strategic Plan

This item contributes to the Board of Supervisors (Board) 2024-2017 strategic priority of Healthy, Safe, and Resilient Communities. This award from the California Governor's Office of Emergency will increase public safety by funding vital equipment and training needed by our first responders.

Discussion:

In accordance with the laws of the State of California, Cal OES requires the submission of the attached Designation of Applicant's Agent Resolution for Non-State Agencies ("Resolution") (Exhibit 1) for the purpose of obtaining certain federal financial assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Act of 1988, and/or state financial assistance under the California Disaster Assistance Act (Government Code § 8680, et seq.). The Resolution is effective for all open and future disasters for up to three years following the date of adoption.

On March 9, 2021, your Board adopted a resolution designating the Sheriff, Assistant Sheriff, or the Director of the Office of Emergency Services as agents of the County of Ventura authorized to execute documents with the California Governor's Office of Emergency Services and the Federal Emergency Management Agency to obtain disaster-recovery funds. This resolution has expired, and Cal OES requires the execution and submission of a new Resolution (Exhibit 1).
