DISCUSSION:


Pursuant to Government Code Section 54974(a), the following unscheduled vacancies were posted in the Clerk of the Board of Supervisors' Office. An unscheduled vacancy must be posted no earlier than 20 days before or no later than 20 days after the vacancy occurs. The notice must be posted for at least 10 working days to allow interested members of the public time to submit an application for your Board's consideration before a final appointment can be made to the board, commission, or committee. The first available date the appointment can be made is identified in the table.

Members of the public who wish to apply to fill the vacancy listed may complete an application for appointment. Applications are available at www.ventura.org/bccapplication and must be submitted to the Clerk of the Board of Supervisors.
