SUMMARY OF VENTURA COUNTY ORDINANCE NO. 4627 WHICH REPEALS VENTURA COUNTY ORDINANCE NO. 4339 AND ESTABLISHES REVISED COUNTY CHARGES FOR PROVIDING COPIES OF PUBLIC RECORDS

The Ventura County Board of Supervisors adopted Ventura County Ordinance No. 4627 on February 27, 2024, in the Board Hearing Room in the Hall of Administration, County Government Center, 800 S. Victoria Ave., Ventura, CA.

The purpose of the ordinance is to repeal Ventura County Ordinance No. 4339 and to establish new County charges for providing copies of public records. Such charges consist of the following: the County's actual costs incurred in printing copies (based on General Services Agency's internal County rates that are currently \$.035 per page for black and white and \$.105 per page for color copies), providing records on data storage devices, mailing copies of records, and charges authorized by Government Code section 7922.575(b). However, charges are waived if the total recoverable cost of fulfilling a public records request does not exceed \$10.00.
