SUBJECT: Receive and File the Unscheduled Vacancy Notice for Kevin Clerici of the Behavioral Health Advisory Board, and the Scheduled Vacancy Notices for Kevin Cannon, Thomas Crocker, Michael Mobley, and William Morris of the Ventura County Resource Conservation District Board of Directors.

RECOMMENDATION:

Receive and file the Unscheduled and Scheduled Vacancy Notices.

DISCUSSION:

Pursuant to Government Code Section 54974(a), the following unscheduled vacancy was posted in the Clerk of the Board of Supervisors' Office. An unscheduled vacancy must be posted no earlier than 20 days before or no later than 20 days after the vacancy occurs. The notice must be posted for at least 10 working days to allow interested members of the public time to submit an application for your Board's consideration before a final appointment can be made to the board, commission, or committee.

Pursuant to Public Resources Code Section § 9314(b)(1), scheduled vacancies to the Ventura County Resource Conservation District Board of Directors will be posted in the same manner as unscheduled vacancies. The first available date these appointments can be made is identified in the table, however, the nominating authority rotates every 2 years.

Members of the public who wish to apply to fill the vacancies listed may complete an application for appointment. Applications are available at www.ventura.org/bccapplication and must be submitted to the Clerk of the Board of Supervisors.
